Zeon LTZ tires size 275/55R20 XL Extra Load tubeless tires are being recalled for failing to meet the standards set out in No. 139 of FMVSS "New Pneumatic Radial Tires for Light Vehicles". The affected tires may experience tread cracking or tread lug chunking during use, causing possible loss of tire pressure and potentially increasing the risk for motor vehicle accident, injury and/or death.

The affected tires were manufactured between September 01, 2015 and September 14, 2015.
