

# Mercedes Being Sued...Again

**Engine defects plague Mercedes once again as they deny any wrong doing; say "It's Normal". This comes after numerous other suits.**

([Newswire.net](#) -- December 28, 2014) Scottsdale, Ariz -- Mercedes Benz USA, LLC has once again been summoned to appear in court over defective engines and the unwillingness to stand behind their vehicles. Based on public information, this suit has been filed in Maricopa County Superior Court on November 3rd, 2014.

The complaint CV2014-055719 in Maricopa County Superior Court, that was filed alleges the vehicle has been out of service for than 47 days during at least 9 different repair attempts since the lease inception, November of 2012. The vehicle was a 2013 Mercedes C63 AMG. The VIN is WDDGF7HB7DA779740 . This particular vehicle is touted by Mercedes as one of their "Most Exclusive" cars they offer. The Mercedes Website uses the tagline "[One Man, One Engine](#)". This lawsuit isn't the first of it's kind. There was [Class Action lawsuit filed in 2012](#) . The Mercedes-Benz Engine Defect Class Action Lawsuit is Majeed Seifi, et al. v. Mercedes-Benz USA LLC, Case No. 3:12-cv-05493, in the U.S. District Court for the Northern District of California. The plaintiffs are represented by Roy A. Katriel of the Katriel Law Firm and Gary S. Graifman of Kantrowitz Goldhamer & Graifman PC.

When Newswire.net reached the Plaintiff regarding this suit, he said "After numerous attempts to make contact to the Dealer, [Schumacher European, LTD](#), and to Mercedes Benz USA, LLC with no resolution, I had no choice but to file a suit. I have bought many cars from Mercedes and I am deeply disappointed that they won't stand behind thier product". The lawsuit also makes note that asidfrom warranty issues the focus of the suit, but while in its final service, [Mercedes Benz of Scottsdale](#) actually caused thousands of dollars in damage when their negligence led to another vehicle initiating the complete replacement of the bumper.
